

RESOLUTION NUMBER R-282449

ADOPTED ON AUG 02 1993

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A GENERAL MUNICIPAL ELECTION AND A SPECIAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON NOVEMBER 2, 1993, WITH THE SPECIAL STATEWIDE ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, the Charter of The City of San Diego provides that the General Municipal Election shall be held on the first Tuesday after the first Monday in November, and

WHEREAS, at a meeting held on August 2, 1993, the City Council adopted Ordinance No. O-17948 (N.S.), calling a General Municipal Election in The City of San Diego on Tuesday, November 2, 1993; and

WHEREAS, at a meeting held on August 2, 1993, the City Council of The City of San Diego adopted Ordinance No. O-17949 (N.S.), calling a Special General Municipal Election in Council District 8; and consolidating said Special General Municipal Election with the Special Statewide Election to be held in said City on Tuesday, November 2, 1993; and

WHEREAS, it is desirable that this General Municipal Election and Special General Municipal Election be consolidated with the Special Statewide Election to be held on the same date and that within the City of San Diego the election precincts, polling places, voting booths and election officials for the

three elections be the same, and that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the General Municipal Election and the Special General Municipal Election and that these Elections and the Special Statewide Election be held in all respects as if there were only one election; and

WHEREAS, in the year 1993, the Special Statewide Election will be held on the 2nd day of November; and

WHEREAS, this Council within the time required by law has or will adopt ordinances calling for a General Municipal Election and a Special General Municipal Election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Board of Supervisors for the County of San Diego is hereby requested to consolidate the General Municipal Election for the office of City Council Districts 1, 3, 5 and 7 and the Special General Municipal Election in Council District 8 to be held in the City of San Diego on November 2, 1993, with the Special Statewide Election to be held on the same date.

2. That the Board of Supervisors is hereby authorized to canvass the returns of the General Municipal Election and the Special General Municipal Election and is requested to conduct the elections in all respects as if there were only one election.

3. That the Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the Special Statewide Election appropriate instructions to take any and all steps necessary for

the holding of a consolidated election.

4. That the City Clerk of The City of San Diego is hereby directed to file a certified copy of this resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to reimburse the County of San Diego for the services performed by the Registrar of Voters for the City of San Diego in connection with the election services herein described in an amount not to exceed \$450,000.

BE IT FURTHER RESOLVED, that The City of San Diego agrees to indemnify and to save free and harmless the County, its officers, agents and employees from expense or liability, including reasonable attorneys fees, as the result of any election contest initiated pursuant to the provisions of Division 13 of the Elections Code of the State of California after conduct of these elections.
