BE IT RESOLVED, by the Council of the City of San Diego that all bids theretofore received on MARCH 4, 1993, pursuant to publication of notice calling for bids on CONSTRUCTION OF PALISADES BUILDING ROOF REPAIRS are hereby rejected.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$21,229.00 from San Diego Facilities and Equipment Leasing Construction Fund No. 91101, to CIP No. 21-830.0, BALBOA PARK PALISADES BUILDING REHABILITATION; and authorizing the expenditure of \$52,689.00 from CIP No. 21-830.0, BALBOA PARK PALISADES BUILDING REHABILITATION, \$21,229.00 from San Diego Facilities and Equipment Leasing Construction Fund No. 91101, \$1,460.00 from

Florida Canyon Capital Outlay Fund No. 302451, \$5,000.00 from Capital Outlay Other Fund No. 302453, and \$25,000.00 from Transient Occupancy Tax Fund No. 102242, to supplement funding authorized by Resolution No. 281481, adopted on February 22, 1993.
