WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of "Washington Street Landscape Maintenance District," under Resolution of Intention No.


R-281987, adopted on MAY 17 1993, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed;
