BE IT RESOLVED, by the Council of The City of San Diego that the low bid of AZTEC LANDSCAPING, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF TORREY HIGHLAND PARK, A MINI-PARK (ENHANCED OPEN SPACE) AND A PORTION OF THE SAN DIEGO GAS & ELECTRIC EASEMENT ADJACENT TO THE PARK WITHIN THE CARMEL VALLEY LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT (CONTRACT 3) as may be required for a period of one (1) year beginning August 1, 1993 through July 31, 1994 per prices on file in the Purchasing Department, for a total estimated annual cost of \$49,390.70; terms 2% 20 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 15%.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to the specifications.
