
RESOLUTION NUMBER R- 2 8 2 4 6 3

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a two month extension from August 1, 1993 through September 30, 1993, of the contract with Burns and Sons Trucking, Inc., for removal and disposal of digested sludge as previously authorized by Resolution No. R-275955 adopted on June 25, 1990.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed two million dollars (\$2,000,000) from Sewer Revenue Fund 41508, is hereby authorized, solely and exclusively, for the purpose of providing funds for the time extension of the above project.
