RESOLUTION OF INTENTION TO ACQUIRE OPEN  
SPACE LAND FOR THE SAN DIEGO OPEN SPACE

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

1. The City Council, for and on behalf of the San Diego Open Space Park Facilities District No. 1, hereby declares its intention to hold a hearing to determine whether or not the District should attempt to purchase certain property, approximately 18.72 acres of Los Penasquitos Canyon Preserve - North #8, for open space park purposes.

3. That no park improvements to said property are presently proposed.

4. That on October 12, 1993, 1993, at the hour of 10:00 a.m., in the Council Chambers, City Administration Building, Charles C. Dail Concourse, 202 "C" Street, San Diego, California, the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.

5. That the owner or owners of said property may appear at the hearing and be heard orally, or by writing signed by them,


