


RESOLUTION NUMBER R- 2 8 2 4 6 9

ADOPTED ON AUG 0 9 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit a proposal to the National Football League to host the Super Bowl XXXI in 1997 at San Diego Jack Murphy Stadium containing the following components: (1) use of San Diego Jack Murphy Stadium at a seating capacity of at least 70,000 at no cost to the NFL; (2) press level facilities modified to accommodate a Super Bowl press corps; (3) the cooperation of all City resources including Police Department, Fire Department, Stadium, Airports, etc.; (4) a guarantee that Stadium concession prices will be held at the same price level as that which prevailed during the previous NFL season; (5) a guarantee that adequate power and communication facilities will be provided for all necessary services; (6) a commitment to cooperate with the NFL to prevent the unauthorized sale of NFL licensed merchandise; (7) adequate practice field facilities at no cost to the NFL; (8) a guarantee that all concession and parking revenues normally due the City will be passed through to the NFL; and (9) a commitment by the City to pay for the expansion of the Stadium.
