BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to return unexpended funds, if any, in the original contract, on file in the office of the City Clerk as Document No. RR-280089, to Penasquitos Trunk Sewer Relief, CIP No. 46-120.0, Object Account 4279.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$2,576,146 from CIP No. 44-001.0, Annual Allocation - Sewer Main Replacements, to CIP No. 46-120.0, Penasquitos Trunk Sewer Relief.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$3,393,600 from Sewer Revenue Fund 41506, CIP No. 46-120.0, Penasquitos Trunk Sewer Relief, is hereby authorized, solely and exclusively for the purpose of providing funds for this agreement, to be expended as follows:

\$2,576,146 from Fiscal Year 1994 appropriations, contingent upon Council approval of funds for this purpose from FY 1994 CIP appropriations

\$125,043 from Fiscal Year 1995 appropriations, contingent upon Council approval of funds for this purpose from FY 1995 CIP appropriations

\$284,015 from Fiscal Year 1996 appropriations, contingent upon Council approval of funds for this purpose from FY 1996 CIP appropriations

\$282,441 from Fiscal Year 1997 appropriations, contingent upon Council approval of funds for this purpose from FY 1997 CIP appropriations

\$125,955 from Fiscal Year 1998 appropriations, contingent upon Council approval of funds for this purpose from FY 1998 CIP appropriations

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
