- 3. That City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$25,000 from CIP 310011, Annual Allocation Brown Field, (Fund 10511, Airports Speed Cap Improv Fund), to CIP 330840, Underground Storage Tank Management Program.
- 4. That the expenditure of an amount not to exceed \$155,000 from CIP 330840, (\$50,000 from Fund 10503; \$25,000 from Fund 10511; and \$80,000 from Fund 302453 Capital Outlay Other), and \$55,000 from CIP 733020, Lake Hodges and San Vicente Gas Tanks (Fund 41500), a total expenditure of \$210,000 for Professional Services and related costs, is hereby authorized,

solely and exclusively for the purpose of providing funds for the above project.
