ADOPTED ON AUG 0 9 1993

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with EMCON Associates, to provide professional services for the Underground Storage Tank Management Program, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 2 8 2 4 8 1

2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$50,000 from Equipment Division Fund 50030, (Central Garage/Machine Shop Fund) to Fund 10503 in order to fund CIP 330840 Underground Storage Tank Management Program.


3. That City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$25,000 from CIP 310011, Annual Allocation - Brown Field, (Fund 10511, Airports Speed Cap Improv Fund), to CIP 330840, Underground Storage Tank Management Program.

4. That the expenditure of an amount not to exceed \$155,000 from CIP 330840, (\$50,000 from Fund 10503; \$25,000 from Fund 10511; and \$80,000 from Fund 302453 Capital Outlay Other), and \$55,000 from CIP 733020, Lake Hodges and San Vicente Gas Tanks (Fund 41500), a total expenditure of \$210,000 for Professional Services and related costs, is hereby authorized,

solely and exclusively for the purpose of providing funds for the above project.
