

WHEREAS, on June 28, 1993, the City Council Committee on Rules, Legislation and Intergovernmental Relations reviewed and approved on consent the Department of Legislative Services (DLS) Report No. 93-22, dated June 20, 1993, concerning Assembly Constitutional Amendment 26 (Aguiar): State mandated local programs: costs, which would amend the California Constitution to provide that no local government may be required by the State to implement a new program or higher level of service unless and until the State provides funds for same; NOW, THEREFORE,
