ADOPTED ON AUG 09 1993

WHEREAS, the Transportation and Land Use Committee on June 15, 1993, discussed the effectiveness of the City's existing adult entertainment dispersal ordinance in mitigating the adverse secondary effects caused by and associated with the concentration of adult businesses; and

WHEREAS, the Transportation and Land Use Committee observed that no study to evaluate the effectiveness of the dispersal ordinance has been done since it was amended on May 26, 1981; and

WHEREAS, the Transportation and Land Use Committee noted that several applications had recently been submitted for new adult entertainment businesses; and

WHEREAS, the Transportation and Land Use Committee directed the City Manager to coordinate a study of the existing dispersal ordinance (San Diego Municipal Code Sections 101.1801 through 101.1899); and

WHEREAS, the Transportation and Land Use Committee unanimously approved preparation of a moratorium on the issuance of permits for new adult entertainment establishments pending completion of the City Manager's study of the existing dispersal ordinance; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager shall coordinate, with staff support from the City Attorney, Planning Department and Neighborhood Code Compliance Department, a study of the City's existing adult

entertainment dispersal ordinance and surrounding conditions to evaluate the dispersal ordinance's effectiveness in mitigating the adverse secondary effects caused by adult entertainment businesses; and

BE IT FURTHER RESOLVED, that any proposals or recommendations made by the City Manager shall be consistent with constitutional principles and case law protecting certain types of adult entertainment; and

BE IT FURTHER RESOLVED, that Chapter X, Article 1, Division 18 of the San Diego Municipal shall be amended by adding Section 101.1840 which provides for the Interim Adult Entertainment Moratorium.
