

RESOLUTION NUMBER R-282500

ADOPTED ON AUGUST 9, 1993

WHEREAS, City of San Diego Administrative Regulation No. 95.25, "Processing New and Revised Fees and Charges for Current Services," requires that City departments annually analyze their services provided to determine if new fees are appropriate and if current fees reasonably recover the costs of providing services; and

WHEREAS, during the annual review of Park and Recreation Department fees, it was determined that four new or significantly revised fees were appropriate; and

WHEREAS, the Golf Advisory Council endorsed all of the proposed golf fees and none of the proposed fees are expected to negatively impact the business community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby approves four new or significantly revised fees for inclusion in the Balboa Park and Torrey Pines Golf Course Fee Schedules, on file in the office of the City Clerk as Document Nos. RR-282500-1 and RR-282500-2.
