BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$1,511,052 from the General Fund (Fund 100), to the Human Care Services Special Fund (Fund 19666), and to expend \$1,511,052 to operate 23 social service programs.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$1,330,319 from Fund 18529 (19th Year CDBG Entitlement), to operate seven social service programs.

BE IT FURTHER RESOLVED, that the City Manager is authorized to extend two agreements for the operation of the Senior Nutrition Program at their FY 1993 funding level for a period of two months.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$91,825 from the General Fund (Fund 100), to the Human Care Services Special Fund (Fund 19666), and to expend \$91,825 for the above stated Senior Nutrition Program agreements.
