APPROVING MAP OF KINGS ROW.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by James L. Hale, Licensed Land Surveyor, entitled "KINGS ROW, being a subdivision of a portion of the Southeast Quarter of Lot 53 of Horton's Purchase, in the Ex-Mission Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 283 filed in the office of the County Recorder of San Diego County, March 9, 1878, together with portions of Euclid Avenue and Ocean View Boulevard as dedicated to public use and a portion of Ocean View Boulevard as closed and vacated to public use pursuant to Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: St. Rita Court and St. Rita Place, and portions of Ocean View Boulevard and Euclid Avenue, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and portions of streets are accepted on behalf of the public as heretofore stated; that those easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, all as granted and shown on the map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
