WHEREAS, the Planning Department has reviewed San Diego Municipal Code section 101.0580 relating to the child care facilities, and has suggested amendments to the code section to streamline the regulatory process as shown in Exhibit A, attached hereto and incorporated by reference; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:



3. That the Planning Commission be directed to hold a public hearing on the matter of the proposed amendments to Municipal Code section 101.0580 and immediately transmit its

recommendations concerning those amendments to the City Council following the hearing.
