BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for STORM DRAIN AT 61ST STREET AND BROOKLYN AVENUE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to Modify the FY94 Capital Improvement budget by adding CIP 12-081.0.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$93,300.00 from CIP 17-001, ANNUAL ALLOCATION - MINOR DRAIN AND SEEPAGE PROBLEMS,

TransNet Fund 30300, to CIP 12-081.0; and authorizing the transfer of \$224,700.00 from CDBG Fund No. 18528 to CIP 12-081.0; and authorizing the expenditure, not to exceed \$318,000.00 (\$224,700.00 from CIP 12-081.0, STORM DRAIN AT 61ST STREET AND BROOKLYN AVENUE, Fund 18528, Dept. 4022; and \$93,300.00 from CIP 12-081.0, TransNet Fund 30300), for the purpose of executing this contract and related costs.
