WHEREAS, Dr. Pleasant was an employee of the City of San Diego for thirty-five years and retired as a Sweep Operator in the Sanitation Department; and

WHEREAS, he has been married to the lovely Esther Pleasant for forty-nine years and has six children - five boys and a girl; and

WHEREAS, the members of Ark Missionary Baptist Church are honoring Dr. H.L. Pleasant for thirty years of faithful and dedicated service as the Pastor of Ark Missionary Baptist Church, where he has inspired not only the members in his church, but the entire community; NOW, THEREFORE,
