WHEREAS, on May 14, 1993, the California Coastal Commission at a public hearing considered an amendment to the San Diego Local Coastal Program to revise the North City Local Coastal Program Land Use Plan to incorporate the 1992 Mira Mesa Community Plan update; and

Coastal Commission, which include reference to regulations in the

the Los Penasquitos Lagoon watershed, have been incorporated into
the Mira Mesa Community Plan; and
