RESOLUTION NUMBER R-282546

ADOPTED ON SEP 13 1993

WHEREAS, on November 5, 1992, the City Heights Community Partnership, a group of community residents and City of San Diego staff, was organized to combine code enforcement, law enforcement improved services in community recreation and library services with direction from the residents of the community; and

WHEREAS, the City Heights Neighborhood Services Team was created in a solid partnership of the community and The City of San Diego and established goals and objectives from the residents and actual team members to work on creating improved City services in the community; and

WHEREAS, the City Heights Neighborhood Services Team is comprised of residents of the community, a Zoning Inspector, a Building Inspector, a Litter Inspector, a Fire Battalion advisor, and a San Diego Police Officer; and

WHEREAS, the Neighborhood Service Team is located in the heart of the community of City Heights at 3705 Highland Avenue, which allows the members to develop relations with the residents and business owners to respond quickly to concerns and problems arriving from citizen complaints and to become an intricate component in the community they serve; and

WHEREAS, in the time since the Team became operational on January 1, 1993, they have conducted over 300 investigations of code violations within the designated areas of City Heights that

evolved from citizen input; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends the City Heights Neighborhood Services Team for their commitment to improve the quality of life in the community of City Heights, to handle neighborhood issues, to be viewed as a model for other communities in The City of San Diego to follow, and for demonstrating that The City of San Diego and neighborhoods can create a partnership to work together to make a difference.
