BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. REID & CLARK SCREEN ARTS CO. and 2. DIMENSIONAL SILK SCREEN, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for purchase of BLANK & PRINTED PLASTIC PANELS as follows:

1. REID & CLARK SCREEN ARTS CO. for Section I - Blank Plastic Panels, for a total estimated cost of \$25,920.00; and for Section III - Printed Plastic "No Parking" Panels, for a total estimated cost of \$27,270.00; terms net 30 days, plus sales tax, with an option to renew the contract for four(4) additional one (1) year periods with price increases not to exceed 10% of the prices in effect at the end of each prior year.
2. DIMENSIONAL SILK SCREEN, INC. for Section II - Printing of Blank Plastic Panels, for a total estimated cost of \$3,600.00, terms 1% 10 days plus sales tax, with an option to renew the contract for four (4) additional one (1) year periods with price increases not to exceed 5% of prices in effect at the end of the prior year.
