ADOPTED ON SEP 13 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. TRUCK HYDRAULIC EQUIPMENT CO., INC. and 2. CALIFORNIA UTILITY EQUIPMENT, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for purchase of FOUR (4) AERIAL LIFT TRUCKS as follows:

1. TRUCK HYDRAULIC EQUIPMENT CO., INC. for Item 1 - three (3) each 14,500 GVW aerial lift trucks (Ford Super Duty with Lift-All LATFB30) at a cost of \$40,089.00 each for a total cost of \$120,267.00; terms net 30 days, plus sales tax.
2. CALIFORNIA UTILITY EQUIPMENT, INC. for Item 3 - one (1) 25,000 GVW aerial lift truck (International with Reach All LM-40 aerial lift) at a cost of \$99,929.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$237,261.19 from Fund No. 50033, Department No. 8203, Object Account No. 6013, and Job Order No. 88084, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
