BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$291,000.00 from CIP No. 35-073.0, EARL AND BIRDIE TAYLOR BRANCH LIBRARY, Fund 79507, Pacific Beach Urban Community Fund, is hereby authorized solely and exclusively for providing funds for said project and related costs.
