RESOLUTION NUMBER R-282581

ADOPTED ON SEP 13 1993

APPROVING PARCEL MAP W.O. 910536.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by James L. Hale, Licensed Land Surveyor, entitled "Parcel Map W.O. 910536, being a division of a portion of the Northeast Quarter of the Southwest Quarter and a portion of the Northwest Quarter of the Southeast Quarter of Section 30, Township 14 South, Range 3 West, San Bernardino Meridian, according to the official plat thereof, in The City of San Diego, County of San Diego, State of California, together with a portion of El Camino Real, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said parcel map and the division of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby presently rejects as a dedication that portion of Parcel 1 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code, but reserves the right to dedicate all or any portion of such reserved area to public street purposes at any time in the future.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the

easements and right-of-way for earth embankment slopes, together with the right to construct and maintain such slopes and embankments and facilities incidental thereto, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council, that said Council has approved said parcel map, and that said Council has for the present rejected a portion of Parcel 1, marked "Reserved for Future Street," and that those easements and right-of-way for earth embankment slopes, as granted and shown on this parcel map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.


