BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute said grant agreement, and the authority of the City Manager shall include all aspects of program operation and expenditures, under the terms and

conditions of the approved grant program proposal, including any amendments or extensions thereof, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said grant.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED, that personnel positions funded by this grant award are not subject to local hiring freezes.
