WHEREAS, the City of San Diego Police Department desires to undertake a certain project designated Indochinese Youth Gang Prevention Project, to be funded in part from funds made available through the single-component Gang Violence Suppression Program administered by the Office of Criminal Justice Planning (hereinafter referred to as OCJP); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to submit the grant proposal, a copy of which is on file in the Office of the City Clerk as Document No. RR-282590, to OCJP, and is authorized to execute on behalf of the City of San Diego the Grant Award Agreement including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered to accept and expend the award funds as described in the grant application.

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute said grant agreement, and the authority of the City Manager shall include all aspects of program operation and expenditures, under the terms and conditions of the approved grant program proposal, including any amendments or extensions thereof, and to certify that the City will comply with all applicable statutory or regulatory

BE IT FURTHER RESOLVED that the applicant agrees to provide all matching funds required for said project (including any amendments thereof) under the Program and the funding terms and conditions of OCJP, and that the cash match will be appropriated as required.

IT IS AGREED that any liability arising out of the performance of the Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
