BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to accept and expend a Petroleum Violation Escrow Account Grant from the California Department of Transportation in the amount of \$478,000 for traffic signal coordination systems on Navajo Road, Jackson Drive, Friars Road and Midway Drive.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an operating agreement with the California Department of Transportation, for the Navajo Road, Jackson Drive, Friars Road and Midway Drive traffic signal systems, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-282595.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish Capital Outlay Grant Fund No. 38524, "Navajo Road, Jackson Drive, Friars Road and Midway Drive Traffic Signal Systems."


