BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$96,000 from CIP No. 29-661.0, Memorial Community Park Improvements, is hereby authorized, solely and exclusively for the purpose of supplementing funds previously authorized by Resolution No. R-280160 adopted on October 19, 1992.
