BE IT FURTHER RESOLVED, that the appropriation and expenditure, not to exceed \$2.3 million in FY1994 from Police Federally Seized and Forfeited Assets funds (Funds 18607, 10118, and 10119), is hereby authorized solely and exclusively for said purchase or lease/purchase of two (2) helicopters plus related
