ADOPTED ON SEP 13 1993

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CALLING FOR THE FORMATION OF A PROJECT AREA COMMITTEE FOR THE PROPOSED SAN YSIDRO COMMUNITY REDEVELOPMENT PROJECT, AND ADOPTING PROCEDURES FOR THE FORMATION OF THE PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the "City Council") by Resolution No. R-278086 adopted on June 10, 1991, approved a redevelopment survey area to study and determine the feasibility of a redevelopment project or projects therein; and

WHEREAS, the Planning Commission, in accordance with the California Community Redevelopment Law (Health and Safety Code section 33000 et seq.) will select a project area for the proposed San Ysidro Community Redevelopment Project and will adopt a Preliminary Plan therefore; and

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is preparing a redevelopment plan for the redevelopment of the proposed San Ysidro Community Redevelopment Project in accordance with the Community Redevelopment Law; and

WHEREAS, pursuant to subdivision (a) of Section 33385 of the Community Redevelopment Law, the City Council shall call upon the residents, businesses and existing community organizations in the project area to form a project area committee; and

WHEREAS, pursuant to subdivision (b) of Section 33385 of the Community Redevelopment Law, the City Council shall, by

resolution, adopt a procedure for the formation of the project area committee; and

WHEREAS, the City Council has published and mailed notice of a City Council meeting this date to consider adoption of a proposed "San Ysidro Community Redevelopment Project - Procedure for Formation of a Project Area Committee" relative to the formation and selection of the Project Area Committee; NOW, THEREFORE;


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Council hereby calls upon the residents and existing community organizations in the San Ysidro Community Redevelopment Project area to form a project area committee in accordance with the Community Redevelopment Law.

2. That the City Council hereby adopts as the procedure for the formation of the project area committee, the "San Ysidro Community Redevelopment Project - Procedure for the Formation of a Project Area Committee," in the form presented at this meeting and placed on file in the office of the City Clerk as Document No. RR- 282609.
