WHEREAS, City, acting through the City Council, has since 1980 approved the San Diego Police Department's Psychological Services Program; and

WHEREAS, City requires professional services of trained and capable psychologists and counselors to perform the following needed services: Education and Training; Trauma Treatment; Crisis Intervention; Confidential Counseling; Family Counseling; Management Consultation; and Miscellaneous Research; and

WHEREAS, these services are provided to sworn and civilian police department personnel on a short term basis at no cost to the employee; and

WHEREAS, contractors are ready, willing, and able to provide needed psychological services to employees of the San Diego Police Department; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Focus Psychological Services, contractors, for continuation of the psychological services for police department employees from July 1, 1993 through June 30, 1998, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 282618 .

BE IT FURTHER RESOLVED, that the expenditures of \$189,600 from Fund 100, Department 110, Organization 320, Object Account 4151 and Job Order 111215, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
