WHEREAS, peace officer applicants shall be judged free from job-related psychopathology, including personality disorders as diagnosed by a qualified professional, to meet minimum requirements of Government Code section 1031(f) established by the State of California's Commission on Police Officer Standards and Training (POST); and

WHEREAS, contractors are ready, willing, and able to provide needed professional services for pre-employment psychological screening of applicants for the San Diego Police Department to determine whether they meet minimum POST requirements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Russell Gold, Ph.D., and Ira Grossman, Ph.D.,

contractors, for continuation of the psychological testing and screening of police applicants from July 1, 1993 through June 30, 1998, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-


