
RESOLUTION NUMBER R- 282621

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Greater Golden Hill Community Development Corporation (CDC) for economic development activities, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 282621, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 from Fund 18529, Dept. 4049, Org. 4908; \$50,000 from Fund 18529, Dept. 4041, Org. 4102; and \$5,000 from Fund 18529, Dept. 4050, Org. 5001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
