
RESOLUTION NUMBER R- 282627

BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 5, dated June 17, 1993, heretofore filed with the City Clerk of said City as Document No. RR- 282627, issued in connection with the contract between The City of San Diego and Mur-Vic Construction Company, Inc., said contract having been filed in the office of the City Clerk as Document No. RR-278715, be and the same is hereby approved, as well as the changes therein set forth, amounting to a net increase in the contract price of \$59,176.19.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$59,176.19, consisting of \$37,692.64 from Sewer Revenue Fund 41506, Construction Outlay (70492), CIP No. 44-001, and \$21,483.55 from Water Revenue Fund 41500, Water Construction Outlay (70592), CIP No. 73-083, is hereby authorized, solely and exclusively to fund this change order.
