WHEREAS, on February 22, 1993 the City Council adopted an ordinance establishing Seal Rock Mammal Reserve to be off limits to human use for a five year trial period; and

WHEREAS, at the same time a resolution was adopted providing for law enforcement and signage; a volunteer docent program; a scientific study of seal use and abuse; and the establishment of an ad hoc committee within the Park and Recreation Board Committee system to oversee the Reserve; and

WHEREAS, members of that Committee were to include representatives from certain marine-oriented organizations as well as representatives of those opposed to the Reserve so that their views would be known and a balance of opinions achieved; and

WHEREAS, those opposed to the Reserve have made their reasons for opposing the Reserve clear and as a result of their opposition, the purpose of the Committee has been inhibited and progress has been delayed; and

WHEREAS, the California Coastal Commission has not been supportive of the Reserve and a hearing date has been delayed pending additional meetings with the staff and a meeting location closer to San Diego to encourage public testimony; and

WHEREAS, City staff believes that the Committee can adequately consider the opposition position without including opponents on the Committee and believes a broader base of
