

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$34,000 in Transnet funds (Fund 30300) from CIP 52-560.0, El Cajon Boulevard from Texas Street to 39th Street, to CIP 39-210.0, City Heights University Avenue Public Requirements for the purpose of completing the design and construction drawings of three blocks of University Avenue.
