

RESOLUTION NUMBER R-282647

ADOPTED ON SEPTEMBER 14, 1993

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby accepts the Planning Department's Work Program as outlined in City Manager Report No. P-93-104, dated September 4, 1993.

BE IT FURTHER RESOLVED, that said City Manager Report No. P-93-104 is hereby amended by:

1. Putting one-quarter person back on the Otay Valley Regional Park and to not delay the Otay Mesa Nestor Community Plan.
2. Accepting Councilmember Wolfsheimer's suggestion for staff to work with the Engineering and Development and Building Inspection Departments to streamline all the processes and dovetail them. Consolidate all of the Zoning Code Update regulations that the departments have in common in the City to have a code of reasonable size. Input those regulations into RUIS and allow the citizens to access RUIS by typing their street address to see what regulations pertain to their property as far as setbacks, height limitations, and zoning limitations.
3. Accepting Councilmember Stevens' request for staff to work with District 4 to determine the cost to update the Southeast Plan. The two reasons for expediting the plan update are: 1) to accomodate economic development in District 4. There

are a number of sites that are residential at the present time yet the feasibility of going commercial would be more positive for economic development; and 2) to have a separate planning , committee for Districts 4 and 8. Presently, one planning committee covers almost two City Council Districts (Districts 4 and 8) and there is a need to have a planning committee for each of those districts.
