ADOPTED ON SEP 27 1993

WHEREAS, 1993 marks the Four Hundred and Fifty-first Anniversary of the European discovery of the West Coast of the United States by Juan Rodríguez Cabrillo on September 28, 1542; and

WHEREAS, the historic moment is also commemorated as the date of the beginning of California; and

WHEREAS, the landing of Cabrillo and his men in San Diego Bay, and his subsequent voyage north along the coast of California, are among the most significant and fascinating chapters in the history of the Americas and most particularly the West Coast; and

WHEREAS, the Cabrillo Festival is recognized throughout California as the basis for recognition of the City of San Diego as the place where California began; and

WHEREAS, the Annual Cabrillo Festival under the sponsorship of a Committee of outstanding civic leaders from the Mexican, Portuguese, Spanish and American communities commemorate this event each September; and

WHEREAS, 1993 marks the 30th Anniversary of the internationally known Cabrillo Festival; NOW, THEREFORE,




