BE IT RESOLVED, by the Council of The City of San Diego that the proposals of 1. CELLMARK DIAGNOSTICS and 2. GENETIC DESIGN INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing DNA TYPING as may be required for a period of one (1) year beginning August 1, 1993 through July 31, 1994 per prices on file in the Purchasing Department, as follows:

1. CELLMARK DIAGNOSTICS for the Primary Contract for an estimated total cost of \$50,000.00 per year; terms net 30 days, with options to renew for four (4) additional one (1) year periods with price escalations not to exceed 5% of the prices in effect at the end of the prior year.
2. GENETIC DESIGN INC. for the Secondary Contract for an estimated total cost of \$10,000.00 per year; terms net 30 days, with options to renew for four (4) additional one (1) year periods with price escalations not to exceed 10% of prices in effect at the end of the prior year.
