BE IT RESOLVED, by the Council of The City of San Diego that the low bid of JONES CHEMICALS, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SODIUM HYPOCHLORITE, 12.5% IN SOLUTION as may be required for a period of one (1) year beginning October 1, 1993 through September 30, 1994. at a cost of \$0.461 per gallon, for a total estimated cost of \$92,200.00; terms net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 30%.

BE IT FURTHER RESOLVED, that in the event the vendor is unable to meet specifications at any time during the contract period, the Purchasing Agent is hereby authorized to terminate the contract and to award to the next low responsible and responsive bidder and to subsequent bidders, if necessary, until a bidder is found who will comply with specifications.
