BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of IMPERIAL WEST CHEMICAL CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing FERRIC CHLORIDE as may be required for a period of one (1) year beginning November 1, 1993 through October 31, 1994, at a delivered price of \$0.1246 per dry pound for a total estimated cost of \$3,738,000.00; terms net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 25%.

BE IT FURTHER RESOLVED, that in the event the contractor fails to deliver material meeting specifications, the Purchasing Agent is hereby authorized to obtain this material on the open market until the requirement can be rebid.
