US RENTALS is hereby approved and the City Manager is hereby authorized to execute contracts for furnishing 5 SPECIFIC RENTAL MOTIVE EQUIPMENT ITEMS as may be required for the period of the first option year beginning August 1, 1993 through July 31, 1994 per prices on file in the Purchasing Department, as follows:

1. BENGAL EQUIPMENT & TRACTOR CO., for the Primary Contract for Item 2, with terms of net 30 days, plus sales tax, with options to renew the contract for three (3) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than the Consumer Price Index.
2. BJ'S RENTAL STORE for the Primary Contracts for Items 3, 4 and 5, with terms of 2% 10 days, with options to renew the contract for three (3) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 10%.
3. CONTRACTORS EQUIPMENT for the Secondary Contract for Item 2, with terms of net, with options to renew the contract for three (3) additional one (1) year periods, with option period

price increases not to exceed the prices in effect for the previous contract period by more than 15%.

4. US RENTALS for the Secondary Contracts for Items 3, 4 and 5, with terms of 1% 10 days, plus sales tax on items 4 and 5, with options to renew the contract for three (3) additional one (1) year periods, with no price escalation.
