BE IT RESOLVED, by the Council of The City of San Diego that the bids of 1. U.S. RENTALS, 2. SAN DIEGO EQUIPMENT RENTALS, INC., 3. BENGAL EQUIPMENT & TRACTOR CO., 4. BJ'S RENTAL STORE, 5. HERTZ EQUIPMENT RENTAL, 6. CONTRACTORS EQUIPMENT COMPANY, 7. MIRAMAR FORD, 8. U.S. RENTALS, and 9. CLAIREMONT EQUIPMENT RENTALS are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing CONSTRUCTION EQUIPMENT AND 5TH WHEEL TRACTOR RENTAL as may be required for a period of one (1) year beginning August 1, 1993 through July 31, 1994, per prices on file in the Purchasing Department as follows:

1. U.S. RENTALS (located in San Diego) for the Primary Contracts for Items 1, 2, 8 and 9, and the Secondary Contracts for Items 5, 6 and 10, with terms of 2% 20 days, with options to renew the contract for four (4) additional one (1) year periods with no option year price increases.
2. SAN DIEGO EQUIPMENT RENTALS, INC. for the Primary Contract for Item 3, with terms of 1% 10 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 10%.
3. BENGAL EQUIPMENT & TRACTOR CO., for the Primary Contract for

Item 4, with terms of net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods with option year price increases not to exceed the prices in effect for the previous contract period by more than the Consumer Price Index.

4. BJ'S RENTAL STORE for the Primary Contract for Item 5, with terms of 2% 10 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not the exceed the prices in effect for the previous contract period by more than 10%.
5. HERTZ EQUIPMENT RENTAL for the Primary Contract for Item 6, and the Secondary Contract for Item 7, with terms of net, plus sales tax, with options to renew the contract for four (4) additional one year periods, with option year price increases not the exceed the prices in effect for the previous contract period by more than 4%.
6. CONTRACTORS EQUIPMENT COMPANY for the Primary Contract for Item 7, with terms of 1% 20 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not the exceed the prices in effect for the previous contract period by more than 10%.
7. MIRAMAR FORD for the Primary Contract for Item 10, with terms of net 30 days, plus sales tax, with options to renew the contract for four (4) additional one year periods, with option year price increases not the exceed the prices in effect for the previous contract period by more than 5%.

8. U.S. RENTALS (located in Chula Vista) for the Secondary Contracts for Items 1, 2, 8 and 9, with terms of 2% 20 days, with options to renew the contract for four (4) additional one (1) year periods with no option year price increases.
9. CLAIREMONT EQUIPMENT RENTALS for the Secondary Contracts for Items 3 and 4, with terms of 2% 10 days, with options to renew the contract for four (4) additional one (1) year periods with no option year price increases.

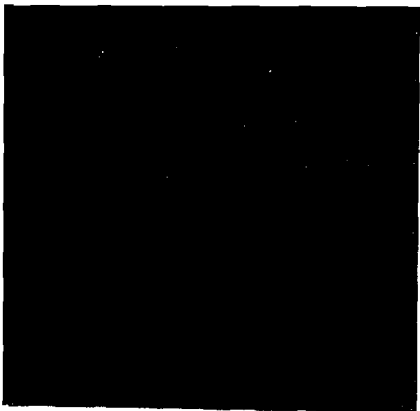
