3. DON'S BACKHOE RENTAL, INC. for the Primary Contract for Item 3 and the Secondary Contract for Item 1, with terms of 2% 10 days, with options to renew the contract for four (4) additional one (1) year periods with no price escalation.
4. RUTLEDGE GRADALLS for the Secondary Contract for Item 3, with terms of net, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 6%.
5. MCDONALD-WESTERN for the Secondary Contract for Item 7, with terms of 3% 20 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 10%.
6. KRAFT WATER TRUCKING for the Secondary Contract for Item 8, with terms of 2% 21 days, with options to renew the contract for 4 additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 5%.
