BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of that deed of BURNHAM PACIFIC PROPERTIES, INC., a California corporation, executed in favor of the City of San Diego, bearing date of August 4, 1993, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 282668, granting to the City a street easement in Parcel 4 of Parcel Map No. 6861, for the potential future improvement of Camino De La Plaza, is hereby authorized.

BE IT FURTHER RESOLVED, that while said deed is not hereby accepted for purposes of immediately dedicating the property to public right-of-way, the City Clerk is hereby authorized and directed to record a copy of this resolution, together with said deed, to indicate, as a matter of record, that the City Council reserves the right at any time in the future to officially accept the easement for public street purposes and to adopt a resolution formally accepting the easement and dedicating the property to public street use.
