WHEREAS, the below referenced 30-acre parcel of land, acquired by the Clean Water Program as offsite mitigation for the North City Water Reclamation Plant Project (CIP No. 42-910.1), is identified in Environmental Impact Report and Mitigation Monitoring and Reporting Program, DEP EIR No. 91-0516 and is required to comply with the requirements of the U.S. Fish and Wildlife Service; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that 30 acres of City-owned land located on Del Mar Mesa north of Los Penasquitos Canyon and Caltrans Vernal Pool Preserve and south of Deer Canyon, as more fully described in that document entitled "Biological Conservation Preserve Restriction," a copy of which is on file in the office of the City Clerk as Document No. RR- 282670, is hereby set aside and restricted for use as a biological conservation reserve, and the City Manager or his designee is hereby authorized to execute, and the City Clerk is hereby authorized to record in the office of the County Recorder, the Biological Conservation Preserve Restriction.
