ADOPTED ON SEP 27 1993

WHEREAS, The Twin Hills Girls Softball Team was formed in 1967 by Miss Debby Gregor, who is considered to be the mother of Twin Hills Softball, with the aide of Mr. Sonny Sinay; and

WHEREAS, the League consisted of two (2) teams with eleven (11) players on each team. The price to register to play in 1967 was \$2.00 and covered twelve (12) games; and

WHEREAS, in 1968 the League grew to a total of five (5) teams. As a result of the largeness of the League, a Board of Directors was established and Ernie Shepherd was elected to be Twin Hills Softball first President; and

WHEREAS, today the Twin Hills Softball Team has a total of twenty-one (21) teams with an average roster of thirteen (13) girls and the Board of Directors consists of sixteen (16) members with Andre Binns as President; and

WHEREAS, there are four (4) Divisions consisting of six (6) Seniors, six (6) Intermediate, six (6) Junior and three (3) T-Ball of the twenty-one (21) teams; and

WHEREAS, The Twin Hills Girls Softball is dedicated to the development, maturity and achievement of success through a program of action for the girls; and


