
ADOPTED ON SEP 27 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to the purchase of service agreement of November 16, 1992 with the American Red Cross, San Diego/Imperial Counties Chapter, for special transportation services, under the terms and conditions set forth in the First Amendment on file in the office of the City Clerk as Document No. RR- 282682, together with any further amendments or modifications which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of the project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$174,345 from Fund 19631, State Transportation Development Act 4.5 Grant Funding, is hereby authorized, solely and exclusively to provide funds for this amendment.
