
ADOPTED ON SEP 27 1993

BE IT RESOLVED, that the San Diego City Council hereby authorizes the City Manager to enter into an Amendment to the Agreement with Dudek and Associates Inc., a copy of which is on file in the office of the City Clerk as Document No. RR- 282687, to increase the contract amount by one hundred thousand dollars (\$100,000), and to extend the duration of the contract for an additional four (4) months, for "As-Needed" Environmental Services.

BE IT FURTHER RESOLVED, that the City Council authorize the expenditure of one hundred thousand dollars (\$100,000) from Clean Water Program Sewer Revenue Fund No. 41509, CIP No. 45-910.3 for the purpose of executing this Amendment to the Agreement.
