

BE IT FURTHER RESOLVED, that the City hereby accepts \$4,945 from the California Integrated Waste Management Board for the purpose of conducting the tire recycling research and publishing the results thereof.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$4,945 from Fund 19303, Object Account 9544, is hereby authorized, solely and exclusively, for the purpose of providing funds for the above project.
